



This document constitutes divisional Special Operations Order as defined by Chapter 10 of IVAO Special Operations Regulations; compliance with this divisional SO Order is mandatory when operating within the concerned division. Divisional Special Operations Order for

Ecuador Division

Item 1. Operational restrictions and mandatory procedures for Special Operations flights

1. Supersonic Operations

- a) All flights over Mach 0.95 are considered supersonic flights.
- b) It is forbidden to reach Mach 1.00 over Ecuador mainland or near Galapagos Islands, all civil supersonic flights will develop it over the Pacific Ocean, and above FL 245.
- c) Military aircraft on a special operation mission corroborated and approved by the Joint Command of the Armed Forces of Ecuador could reach Mach 1.00 at FL245 or Above, and near unpopulated areas for Ecuador Mainland.
- d) The maximum speed for training proposes on special areas is Match 0.98.

2. Low-Level Rules

- a) For fixed-wing aircraft is mandatory to fly 1 000 Ft above terrain and 500 Ft above the sea.
- b) For rotorcraft is mandatory to fly 500 Ft above the terrain.
- c) Search and Rescue (SAR) aircraft on a special operation mission are excluded for 2.a and 2.b rules.
- d) The maximum speed below FL100 will be 300 Knots.

3. Miscellaneous

- a) Military and SO aircraft must contact civilian ATC, expect when they enter to a special area.
- b) Civilian ATC should segregate military aircraft according to their mission.
- c) It is forbidden foreign military aircrafts supersonic flights over Ecuador mainland, Galapagos Islands and Ecuador Territory Sea, although it be a multinational military exercise and they must follow these regulations.
- d) All military aircraft must fill their flight plan under Military Rules "M".
- e) Any member who wants to control at a Military ATC position must request approval by EC-SOC.
- f) To enter a special zone, the aircraft must receive an ATC clearance, if there is not an ATC position connected any non-SO aircraft must not enter a special area.
- g) Civilian ATC could control special zones (Expect SEP-1 and SER-2 "Taura") according to the traffic situation, experience, and, as required by traffic.
- h) To enter a special zone, the traffic should report to ATC:
 - Current callsign.
 - Tactical callsign (if applicable).
 - Aircraft type.
 - Souls on board.
 - Fuel remaining.



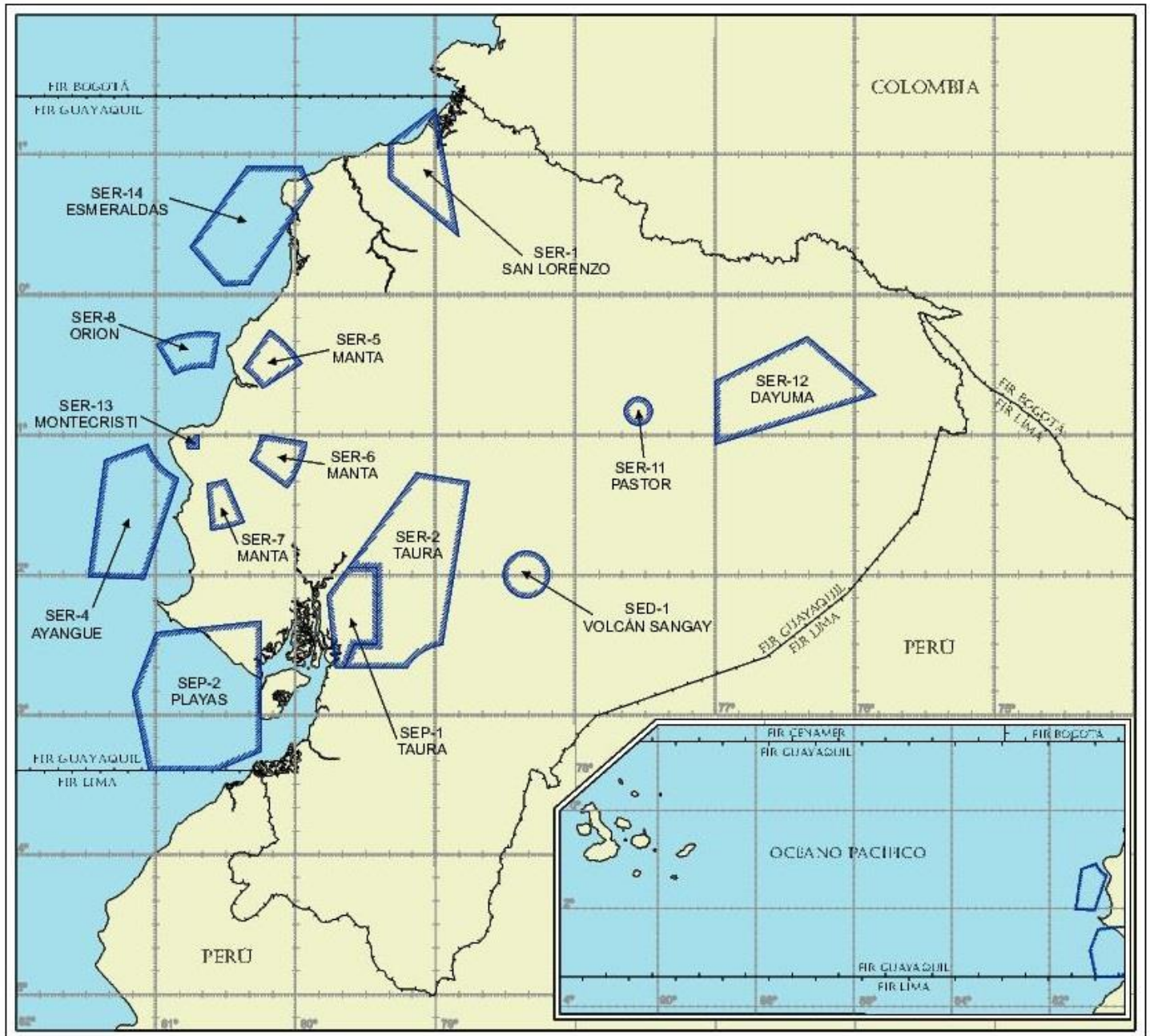
- Intentions.
