


This document constitutes divisional Special Operations Order as defined by Chapter 10 of IVAO Special Operations Regulations; compliance with this divisional SO Order is mandatory when operating within the concerned division. Refer to SO Regulations available at http://sod.ivao.aero/regulations.

Divisional Special Operations Order for

Cuban Division

Item 1. Operational restrictions and mandatory procedures for Special Operations flights

- 1.1 The crossing of active restricted airspace can be achieved with permission from an active SO ATC Unit/ Civil ATC Unit responsible for the said restricted area, ONLY if safety and separation is maintained. If there is no ATC available, traffic not involved in SO activity shall not enter the airspace under any circumstance.
- 1.2 Only IVAO CUBA Members can use Cuban Military Callsigns (DAAFAR)
- 1.3 All flights with <u>Military callsigns</u> must mark on Flight Plan -> Type of Flight: M Military
- 1.4 All flights with <u>CALLSIGN</u> of other <u>governmental</u> security entity must mark on Flight Plan: Type of Flight: X Other
- 1.5 Supersonic Flights in Cuba ONLY for Flight Plan M and X
- 1.5.1 Speed restrictions for SO INSIDE Segregated Airspace: none
- 1.5.2 Speed restrictions for SO OUTSIDE Segregate Airspace:
- 1.5.2.1 From Ground to FL100 level: 350 knots
- 1.5.2.2 From flight Level FL100 to FL400 Mach 0,95
- 1.5.2.3 From FL400 and above ALL RESTRICTIONS WILL BE LIFTED
- 1.5.2.4 If there is MILITARY ACTIVE ATC CONTROL, Supersonic Speeds may be requested but not in the airways, and my be parallel to the airways or directly, however, always with Military ATC Approval.
- 1.6 CUBA Non-Special Operations Events: During all Cuban Civil Events, ALL Special Operations Flights must use the Military or Naval Air Bases or Stations, under no circumstances any military flight without DIR/ADIR/SOC/SOAC authorization must be done close to the Civil Airports of the Events.





- 1.7 Interceptions, targeting, or escorting:
- 1.7.1 Only IVAO CUBA Members can conduct Targeting. Inside segregated airspace, users may conduct targeting without the requirement of an online ATC inside any segregated airspace published under item 1 of the Division's current approved Special Operations Order
- 1.7.2 Interceptions only can be done under SO-NOTAM sent by CU-DIR/CU-ADIR/CU-SOC/CU-SOAC where it has to be informed of the segregated airspace, time and Airplanes involved.
- 1.7.3 Escorts can only be conducted by approved SOGs under SO-NOTAM sent by CU-DIR/CU-ADIR/CU-SOC/CU- SOAC where it has to be informed of the route followed, times, flight plan, and airplanes involved.
- 1.8 During Divisional events, guidance and navigation support services may only be offered at events with the express authorization of CU-DIR/CU-ADIR/CU-SOC/CU-SOAC or anymember of the Cuba Special Operations Department.
- 1.9 Military Control Positions
- 1.9.1 No GCA Military control Positions are reserved for active members of the Special Operations Cuban Division, any Guest using these dependencies may be disconnected by a Supervisor.
- 1.9.2 GCA Military Control Positions will be unlocked by CU-DIR/CU-ADIR/CU-SOC/CU-SOAC as needed using the information, frequencies, and callsigns on this SO Order.
- 1.10 Any modification of this SO Order may be done with SO-NOTAM published on Cuba Forum.


